Centris Federal Credit Union Tap to Pay and Give Your Way Giveaway ("Tap to Pay and Give Your Way Giveaway")

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.
- 2. SPONSOR: Centris Federal Credit Union, 13120 Pierce St Omaha, NE 68144
- 3. ELIGIBILITY: The Tap to Pay and Give Your Way Giveaway is open only to legal residents of the fifty (50) United States and District of Columbia who are 19 years of age or older as of November 20, 2024, and have a valid driver's license. - **4. TAP TO PAY AND GIVE YOUR WAY GIVEAWAY TIMING:** Begins at 08:00:00 AM Central Time ("CT") on November 20, 2024, and ends at 11:59:59 PM CT on January 15, 2025 ("Promotional Period").
- 5. TO ENTER: There are two (2) methods to enter: 1) <u>Automatic Entry</u>: All eligible Centris Visa® consumer and business Debit Card holders will automatically receive one (1) Tap to Pay and Give Your Way Giveaway entry for each eligible Centris Visa® Debit Card purchase made during the Promotional Period at a participating merchant location in the U.S.
 - Only eligible Visa® purchases or payments made with a Centris Visa® Debit Card that are not in default under the member agreement for that account and issued by Centris in the U.S., processed through Visa® U.S.A. Inc.'s transaction- processing system during the Promotional Period are eligible for automatic entry. There are no maximum number of entries earned via this method. In the event of a dispute as to who submitted a particular card holder entry, such entry will be deemed to be submitted by the primary person in whose name the card used to enter the Tap to Pay and Give Your Way Giveaway was issued. Account adjustment transactions/returns, cash advances, balance transfers, non-U.S.- dollar purchases, Interlink®-processed transactions, payment of late fees, fraudulent transactions or over-limit fees are excluded from automatic entry.  - <u>2) To enter without purchase or obligation by U.S. Mail:</u> Handprint your name, address, city, state, ZIP code, and daytime and evening telephone numbers (including area code) on a 3.5" x 5" card, and mail, in a #10 envelope with postage affixed, to: Tap to Pay and Give Your Way Giveaway, Centris Federal Credit Union, 13120 Pierce Street Omaha, NE 68144. Mail-in entries must be postmarked by January 15, 2025, and received by January 24, 2025, in order to be eligible. There are no maximum number of entries for Mail-in entries. An entry that is mechanically reproduced, copied, illegible, incomplete, or inaccurate and entries by any means which subvert the entry process are void. Entries become the property of the Sponsor and will not be acknowledged or returned. Incomplete entries or entries not complying with these Official Rules are subject to disqualification, at the Sponsor's sole discretion. Proof of mailing does not constitute proof of delivery. Void where prohibited.
