Nominations by Petition

Voting Procedures

An election will not be conducted by ballot, and there will be no nominations from the floor, when there is only one nominee for each position to be filled. If a petition for nomination is submitted, an election by ballot would take place with each qualified member of Centris who is at least 18 years of age receiving a ballot by mid-February. Ballots would be mailed to the address listed on your account. Complete instructions would be included in each mail ballot packet.
