

# Official Rules

## Centris Federal Credit Union Auto Payments for a Year Giveaway ("Auto Payments Giveaway")

### Up to \$10,000 for 12 consecutive monthly payments

**Promotional Period:** The Promotion begins on December 15, 2018 at 12:00 a.m. Central Standard Time and ends on December 13, 2019 at 6:00 p.m. Central Standard Time (the "Promotional Period").

**Eligibility and Restrictions:** During the Promotional Period, when you open or refinance a Centris Federal Credit Union auto loan in Nebraska or Iowa, you will automatically be entered to be drawn as a winner in the Auto Payments Giveaway.
